I have agreed to participate in training activities on property owned by Lake County, Illinois ("County") and in the possession of the Great Lakes Disaster Training Foundation ("GLDTF") commonly known as the Lake County Advanced Response Training Academy ("LCARTA") located at 15900 W. Russell Road, Zion, IL ("Site"). I understand that neither the County nor GLDTF controls the training exercises being held at LCARTA and that GLDTF's sole responsibility is to provide access to the property along with permanent and temporary improvements and trade props (collectively, "Trade Props") located or to be located thereon. I understand that the training exercises located at LCARTA that I will be participating in may be hazardous and may result in bodily injury or death and that participation in the training exercises is at my own risk. In consideration of the County and GLDTF making the Property and the Trade Props available for such training exercises, I hereby waive and fully release and discharge, for myself and my personal representatives, heirs, successors, assigns and other persons claiming by, through, or under me (collectively "I"), the County, GLDTF and each of their respective board members, agents, officers, contractors, employees, insurers, assigns and licensees (collectively, "Releasees") from any and all claims, demands liabilities, debts, obligations, causes of action, damages and attorney's fees (collectively, "Claims"), foreseen or unforeseen, of whatever kind or nature, which in whole or in part I have or in the future may have against any of the Releasees arising out of, or based on or in any way connected with my presence on the Site, use of any Trade Props or participation in the training exercises. I further covenant and agree, with respect to any Claims, not to sue Releasees. This Waiver shall be governed by the internal laws of the State of Illinois. If any provision of this Waiver shall be deemed unenforceable under applicable law, such provision shall be ineffective, but only to the extent of such unenforceability, without invalidating the remainder of such provision or the remaining provisions of this waiver. No statements, representations, promises or inducements, oral or written or otherwise have been made to me concerning the subject matter hereof except for those set forth in this Waiver. I have read and fully understand the meaning and effect of this Waiver. I am aware that this document is a waiver of claims, a release of liability and covenant not to sue and intend to be legally bound having voluntarily signed below.
